

UGI Utilities, Inc. Sustainable Santa Sweepstakes Official Rules

UGI Utilities, Inc. is proud to offer the Sustainable Santa Sweepstakes!

HOW TO ENTER: NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes begins at 12:00AM ET on December 12, 2016 and ends at 11:59 PM ET on December 21, 2016 (“**Entry Period**”).

You may enter this Sweepstakes by logging into your Facebook® account and uploading a photo to UGI Utilities, Inc.’s page of energy saving efforts around your home in compliance with the terms and conditions of these Official Rules. In order for your uploaded photo to qualify you to enter the Sweepstakes, the photo and the circumstances surrounding your uploading the photo must be uploaded in accordance with Facebook®’s Terms of Use (<https://www.facebook.com/legal/terms>). Each uploaded photo that satisfies these Official Rules constitutes **two entries** into the Sweepstakes. Any comment with an energy savings effort around your home to UGI Utilities, Inc.’s page constitutes **one entry** into the Sweepstakes.
