

The UGI Utilities, Inc. Heroes of Hope Sweepstakes

Official Rules

UGI Utilities, Inc. is proud to offer the Heroes of Hope Sweepstakes!

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

PROMOTION PERIOD: This Sweepstakes begins at 12:00AM ET on July 1, 2020 and ends at 11:59 PM ET on August 25, 2020 (“**Promotion Period**”).

HOW TO ENTER: All entries must be received online by visiting www.ugi.com/heroesofhope and completing the entry form. A completed entry form must contain the entrant’s nomination of a Hero of Hope and an explanation of why they nominated their Hero of Hope. Both the entrant and the nominated Hero of Hope are then entered into three random prize drawings. If the entrant’s completed entry form is selected in any of the three random prize drawings, the entrant will receive a \$100 Amazon® eGift card (the “Nominator Prize”) and the entrant’s nominated Hero of Hope will receive a \$500 Visa® gift card (“Hero of Hope Prize”). The odds of winning depend on the number of qualifying entries received. Limit one entry per person. Entries must be received during the promotion period. Winners will be selected randomly from eligible entries received during the Promotion Period. Use of any robotic, automatic, programmed or similar entry method or more than one Entry during the Promotion Period will void all Entries of such entrant and result in disqualification. ELIGIBILITY: This Sweepstakes is run by UGI Utilities, Inc. (“**Sponsor**”). This Sweepstakes is open only to persons who are 18 years of age as of July 1, 2020, and who are legal residents of the United States. Employees, their immediate families, and household members (whether related or not), of Sponsor, and their affiliates, subsidiaries, divisions, advertising, judging, and promotion agencies, and respective employees of each (collectively “**Sponsor Parties**”) are not eligible. This Sweepstakes is subject to all United States federal, state, and local laws. Sponsor reserves the right to verify the eligibility qualifications of each Winner (as defined below).

DETERMINATION OF WINNER: At the end of the Promotion Period, Sponsor will conduct three random drawings from all eligible entry forms received during the Promotion Period. The nominated Hero of Hope on the selected entry form will win one of three (3) \$500 Visa® Gift Cards (the “Hero of Hope Prize Winner”). The person that nominated the Hero of Hope Prize Winner on the entry form (“Nominator Prize Winner”) will win a \$100 Amazon® eGift card. Hero of Hope Prize Winners and Nominator Prize Winners will be notified via Facebook® or, if Hero of Hope Prize Winner and/or Nominator Prize Winner is not a Facebook® member, via email, no later than August 31, 2020. Each winning entry will be confirmed by appropriate employees of Sponsor whose decisions are final on matters relating to this Sweepstakes.
