

## UGI UTILITIES, INC

### Commercial Prospect Promotion (“Program”) Terms and Conditions

**BACKGROUND:** UGI Utilities, Inc. – Gas Division (UGI) is offering a \$75 gift card (“Reward”) to commercial businesses with properties near existing UGI-owned natural gas main in exchange for an authorized business representative meeting with a UGI sales representative to discuss conversion to natural gas.

**PROMOTION PERIOD:** The Commercial Prospect Promotion (“Promotion”) begins at 12:00 AM ET on 4/15/2021 and ends at 11:59 PM ET on 9/30/2021 (“Promotion Period”).

**ELIGIBILITY:** In order to receive the “Reward” the business must meet the following qualifications:

- The business must be located proximately to UGI-owned natural gas main, as determined by location of parcel address in UGI’s lead management system, Fieldbook;
- A business representative with authority to convert the business to natural gas (“Authorized Representative”) must meet, either in-person or virtually, with a UGI representative to discuss converting to natural gas;
- The Authorized Representative must be at least 18 years of age;
- The Authorized Representative must complete an online form including Name, Service Address and/or Mailer ID, Phone number and Email address; and
- The Authorized Representative must agree to Promotion Terms and Conditions.

Existing UGI natural gas customers and residential properties are not eligible for this Promotion. No purchase of product or service is necessary.

**PROGRAM PARTICIPATION:** UGI will send solicitations, via direct mail, email and digitally, to commercial prospects whose parcel address is located near existing UGI-owned natural gas main. If interested, the prospect will be directed to a landing page to complete a short form providing their contact information. Once the form is completed, UGI will confirm that the address is eligible and a UGI sales representative will reach out and schedule a 30-minute meeting (virtual or in-person). At the completion of the meeting, UGI will email the participant a link to redeem a \$75 gift card at Reward Genius by Tango Card within 5-business days. The Authorized Representative who completes the form will also receive periodic email messages from UGI explaining the benefits of natural gas and the process of converting to natural gas. The Authorized Representative may unsubscribe to emails at any time by clicking the Unsubscribe link at the bottom of every email.

Gift cards are issued by UGI using Rewards Genius by Tango Card. UGI reserves the right to provide you with an alternative form of consideration of equal value at its discretion. A valid email address is required for receipt of gift card. Gift cards do not have cash access.
