

2021 UGI GIVEAWAY SWEEPSTAKES

Official Rules

ENTRY PERIOD. This 2021 UGI Giveaway Sweepstakes ("Sweepstakes") begins at 12:00 AM ET on September 1, 2021 and ends at 11:59 PM ET on November 30, 2021 ("**Entry Period**").

SPONSOR: The "**Sponsor**" of this Sweepstakes is UGI Utilities, Inc., located at 1 UGI Drive, Denver, PA 17517.

ELIGIBILITY: Employees, their immediate families, and household members (whether related or not), of Sponsor, and their affiliates, subsidiaries, divisions, advertising, judging, and promotion agencies, and respective employees of each (collectively "**Sponsor Parties**") are not eligible to participate in the Sweepstakes. Existing natural gas customers of Sponsor as of the Sweepstakes start date are not eligible to participate in the Sweepstakes. Eligible Sweepstakes participants are limited to Sponsor's applicants and customers that are: 1) approved for participation in Sponsor's GET Gas program; 2) seeking new natural gas distribution service at the customer's or applicant's address from Sponsor; 3) converting an existing non-gas powered heating system to a gas powered heating system. This Sweepstakes is subject to all United States federal, state, and local laws. Sponsor reserves the right to verify the eligibility qualifications of each Prize Winner.

Additionally, this Sweepstakes is open only to eligible persons who are eighteen (18) years of age as of January 1, 2021, who are legal residents of Pennsylvania, and who own a property in one of Sponsor's GET Gas Project areas depicted in Appendix A. Void in all other states and territories, including Puerto Rico, and where prohibited.

HOW TO ENTER:

There are two methods of entry for this Sweepstakes. Eligible individuals may enter the Sweepstakes if they do not currently receive natural gas service at their eligible property address located in one of the GET Gas Project areas depicted in Appendix A, and the eligible property address has a heating system that is capable of being converted to receive natural gas distribution service from Sponsor in the ordinary course of the Sponsor's GET Gas natural gas service installation program (the conditions of qualification in the GET Gas program are specified in Sponsors' current Gas Tariff, which may be amended from time to time and accessible at UGI.com). Eligible individuals may enter the Sweepstakes by:

- 1) Submitting a complete entry form online at Sponsor's GET Gas Sweepstakes entry page (www.ugi.com/getgasentryform).

OR

- 2) Provide your name, address (which, as stated above, must be located in one of the GET Gas Project areas depicted in Appendix A), phone number, email address, age, and include "UGI GIFT GIVEAWAY" in a writing to 1 UGI Drive, Denver, PA 17517, attention Sales and Marketing Administrative Assistant.

All entries must be received by Sponsor on or before 11:59 PM ET on November 30, 2021 (the "Deadline"). The odds of winning depend on the total number of qualifying completed entries

received by Sponsor. You are responsible for any fees associated with internet access, device usage charges, or any other charges incurred in connection with your entry.

PRIZES: Sponsor will review all entries received by the Deadline and randomly select one **“Grand Prize Winner”**, and three (3) **“Second Prize Winners”** (each, a **“Prize Winner”**). The Grand Prize Winner will win \$5,000.00 to be paid by check. Each of the three selected Second Prize Winners will win \$3,500.00 to be paid by check.

The payments will reimburse each Prize Winner for part of their cost of converting their existing non gas-powered heating systems to natural gas powered heating systems at their respective eligible property addresses, located in one of the GET Gas Projects depicted in Appendix A, as specified in the Prize Winners’ entry documents.

Such conversions must be completed and paid for by the Prize Winners and installed at the eligible property addresses located in one of the GET Gas Project areas depicted in Appendix A, as specified in the Prize Winners’ entry documents. However, such conversions must be paid for and completed by the Prize Winners within one hundred and eighty (180) days of the Prize Winners being notified of their prize selection.

Additionally, Prize Winners must provide Proof to Sponsor demonstrating: (1) that the Prize Winners are the owners of their respective eligible property addresses where existing heating systems will be converted to gas, including, but not limited to, a copy of a deed, property tax bill or home owner’s insurance bill; and (2) that the Prize Winners purchased and installed a qualifying natural gas heating system at the applicable eligible property address within one hundred eighty (180) days of being notified that they are a Prize Winner. Sponsor may delay payment of prize winnings until the conversion equipment is installed within the one hundred and eighty- (180-) day conversion period. Proof of conversion must be provided to Sponsor within one hundred and eighty days (180) of being notified that they are a Prize Winner. Prize Winners must sign an Affidavit of Eligibility, Consent to Publicity, Liability Waiver, and federal and state tax release (W-9 form) (the “Documents”), all of which must be fully completed, executed and returned to Sponsor within thirty (30) days of the issuance of notification of being a Prize Winner or such other date set forth in the notification by Sponsor. Failure to comply with all instructions in a Prize Winner notification, or if Prize Winner does not agree to provide the required Documents, fully completed and executed, within thirty (30) days of Prize Winner notification, or if a Prize Winner does not provide the required Proof of conversion within one hundred eighty (180) days of being notified that they are the Prize Winner, Sponsor may select an alternate Prize Winner resulting in disqualification of the Prize Winner.

The prizes described herein are hereinafter referred to as, the **“Prize(s).”** For the avoidance of doubt, the Prize amounts specified above will only reimburse the Prize Winners for direct costs of labor and materials that the Prize Winners incurred in converting to a natural gas central heating system from some other fuel source. Any federal, state, and local taxes and any duties on a Prize are the sole responsibility of the Prize Winner. Prizes are non-transferable. No substitution or transfer of a Prize is permitted.

The random selection of the Prize Winners will occur on or about December 10, 2021. Prize Winners will be notified via email on or before December 24, 2021. Each winning entry will be confirmed by appropriate employees of Sponsor whose decisions are final on matters relating to this

Sweepstakes. Sponsor is not responsible for any changes to a Prize Winner's email address or other information which may interfere with winner notification.

CONDITIONS OF ENTRY: An eligible entrant must enter by completing the entry procedures as described in these Official Rules. Only one (1) entry may be submitted per existing customer's/applicant's account. All entries submitted that are not in compliance with these Official Rules are void. Incomplete entries are void, including any inappropriate, incomplete or duplicative entries. Neither Sponsor, nor Sponsor Parties, assumes any responsibility for late, lost, illegible, misdirected or postage-due entries. Any entrant that provides materially false information shall be disqualified. By entering, entrants accept and agree to these Official Rules, including all eligibility requirements. All entries become the property of Sponsor. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. By submitting any information or content to Sponsor Parties, you represent that you have the full legal right to provide such information and that use of the information by Sponsor Parties will not (a) infringe any intellectual property rights of any person or entity or any rights of publicity, personality, or privacy of any person or entity; (b) violate any law, statute, ordinance, or regulation; or (c) constitute disclosure of any confidential information owned by any third party.

RELEASE: The information provided by Sponsor in connection with the Sweepstakes is for informational purposes only. Upon submission of your entry, or other material or information to Sponsor in connection with this Sweepstakes, you grant Sponsor Parties a universal, perpetual, non-terminable, irrevocable, transferable, license to access, use, distribute, perform, reproduce, display, modify, create derivative works based upon, and sublicense such information and content for the purpose of providing the Sweepstakes, Prizes and for all other business purposes of Sponsor.

By entering this Sweepstakes, you hereby certify that you have complied with all the official rules of this Sweepstakes and that you have committed no fraud or deception in entering this Sweepstakes or in claiming any Prize. By entering this Sweepstakes, you grant Sponsor Parties the right to print, publish, broadcast, and use universe-wide in any media now known or later developed at any time or times, your name, portrait, picture, voice, likeness, and biographical information for any purpose, including for advertising and promotional purposes without additional consideration, except where prohibited by law.

Sponsor Parties reserve the right in their sole discretion to disqualify any individual found to be tampering with the entry process or the operation of this Sweepstakes or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. When used herein, the words "includes" and "including" and their syntactical variations shall be deemed followed by the words "without limitation." ANY ACT OR ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ACT OR ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ACT OR ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

CHOICE OF LAW AND JURISDICTION: All applicable federal, state, provincial and local laws and regulations apply. This Sweepstakes and all matters, issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants, Prize Winners, and Sponsor in connection with this Sweepstakes, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania of the United States, without giving effect to any choice of law or conflict of law rules or provisions (whether of the Commonwealth of Pennsylvania or any other jurisdiction), which might otherwise cause the application of the laws of any jurisdiction other than the Commonwealth of Pennsylvania. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these

Official Rules shall be brought only in the courts of the Commonwealth of Pennsylvania, located in Berks County, or the United States District Courts of the Commonwealth of Pennsylvania located in Berks County.




Eligible GET Gas Project Areas

Properties must be located within the boundaries outlined in pink in the satellite images below.


Flint Ridge – Cumru Township, Berks County
