#### Applicant must be a UGI Utilities, Inc. – Electric Division (UGI) customer.

Program Dates: 06/01/23 – 5/31/24; requests must be postmarked within 180 days of purchase.

Funds are limited, and UGI Utilities reserves the right to extend, modify or terminate the rebate program at any time.

#### To receive your UGI rebate by mail, carefully follow these steps:

- 1. Mini split heat pumps and central air conditioner models that have earned the ENERGY STAR certification are identified in the Air-Conditioning, Heating, and Refrigeration Institute (AHRI) online database. Confirm product eligibility by visiting https://www.energystar.gov/productfinder/ and to obtain your AHRI Certified Reference Number.
- 2. Purchase a Qualifying ENERGY STAR<sup>®</sup> Certified Product during the program dates listed above. Must be installed in a residential property within UGI's electric service territory (Luzerne and Wyoming County).
- 3. Return the completed and signed application along with a copy of a dated, paid in full invoice / receipt showing:
