Funds are limited, and UGI Utilities reserves the right to extend, modify or terminate the rebate program at any time.

To receive your UGI rebate by mail, carefully follow these steps:

- 1. Confirm product eligibility by visiting <https://www.energystar.gov/productfinder/> and to obtain your AHRI certified reference number.**
- 2. Purchase a qualifying ENERGY STAR® certified product during the program dates listed above.
Must be installed in a residential property within UGI's electric service territory (Luzerne and Wyoming County).**
- 3. Return the completed and signed application along with a copy of a dated, paid in full invoice /receipt showing:**

Additional information regarding eligibility and products may be found in the programs and rebates section at www.ugi.com/savesmart; Rebate valid for qualified appliances purchased and installed between June 1, 2025 and May 31, 2027; Rebates are subject to available program funding; Applications are subject to audit and verification by UGI.
